5. To engage with all writing prompts and activities during the Summer Institute.
6. To implement in your own classroom and school best practice strategies for incorporating Indian Education for All, teaching writing and reading learned during the Summer Institute.
7. To make two presentations to your colleagues during the coming school year and to contribute to other state-wide, writing project or school district activities as mutually agreed upon between Teacher-Consultant and school/writing project administrators.
8. To participate in Montana Writing Project evaluations and follow-up activities as needed.
